> A fixed magazine rifle has no magazine release. A ten round magazine is secured into the lower receiver during the time of manufacturing. The rifle is born a top-loading rifle. It was never modified and it can never be modified to accept a detachable magazine.

To load the firearm you can either use an ejection port loader, or if you do not have one, simply pull the extended rear take-down pin to break the action, and manually load the magazine from the top.

MD (HBAR)

A standard rifle is a semi-automatic rifle with a detachable magazine and all of the standard features.

This includes, but is not limited to a pistol grip, an adjustable stock, a threaded barrel, and a muzzle device.

Additional features may be added, such as a vertical front grip, a bayonet or a folding stock adapter.

Standard rifles ship with a 30 round magazine.

FEATURELESS

Legal in NY, CA, DE NOT legal in CT, MA, IL or WA



A featureless rifle is a semi-automatic rifle which has the ability to accept a detachable magazine. Therefore, all of the "features" must be removed. There is no pistol grip, no adjustable stock, no thumb hole stock, no threaded barrel, no muzzle device, no bayonet lug, no bayonet, no grenade launcher, and no secondary front grip to be help with the non-firing hand.

We offer at least three different versions of a featureless rifle using different grip/stock combinations.

A featureless rifle will ship with a 10 round magazine.

POST BAN

Legal in NJ

A post ban rifle is a semi-automatic rifle which has the ability to accept a detachable magazine. You are allowed one feature as per the 1994 "assault weapon" ban. Most users choose to keep the pistol grip as their one feature. A post ban rifle can also have a muzzle brake or compensator, but it must be pinned and welded.

A post ban rifle will ship with a 10 round magazine.

FIREARM NON-NFA

Legal in, NJ, DE, and MD NOT legal in NY, MA, CA, IL or WA

A non-NFA firearm is a semi-automatic firearm which has the ability to accept a detachable magazine.

It does not have a stock and is not intended to be fired from the shoulder, therefore it is not a rifle.

It has two grips and is intended to be fired using both hands, therefore it is not a pistol.

It has an overall length greater than 26" in its shortest firing position, therefore it is not an AOW, and does not require a tax stamp.

A non-NFA firearm will ship with a 10 round magazine. Free states may use any capacity magazine.
